Reunion Room Block

The reunion room block consists of **65 rooms**. Based on discussions with the hotel, there should be ample availability of both **King Bed** and **Double Queen** room types.

Discounted rooms are limited and will be available on a first-come, first-served basis.

Room Occupancy Information

When making reservations online, the booking system currently allows guests to reserve rooms with **up to two occupants**.

The individual making the hotel reservation should provide accurate occupancy information based on the number of guests staying in the room. Additional occupancy charges apply for rooms with more than one guest. These charges help cover additional services that may be required, including extra towels and housekeeping accommodations.

Current hotel rates per night are:

- Single Occupancy: \$185/night
- Double Occupancy: \$195/night
- Triple Occupancy: \$205/night
- Quadruple Occupancy: \$215/night

Guests who have questions regarding room occupancy, rates, or applicable charges are encouraged to contact the hotel directly for clarification when making their reservation.



Room Type Selection

When making your reservation, you will reserve the number of rooms needed. The hotel room block includes both **King Bed** and **Double Queen** room types.

Because the reunion room block does not have a predetermined allocation of King versus Double Queen rooms, room types will be assigned based on availability.

Additional Room Accommodations: One (1) rollaway bed and one (1) crib are permitted per guest room, subject to hotel availability.

Guests may contact the hotel prior to arrival to request a preferred room type and/or additional room accommodations, or inquire at check-in; all requests are subject to availability.

Hotel Reservation Deadline

The deadline to reserve a room at the discounted reunion rate is:

Thursday, June 17, 2027

Reservations after this date may be subject to standard hotel rates and availability if rooms remain available.

We encourage family members to register early and reserve accommodations once the hotel booking link is received to ensure access to the discounted room block.
